



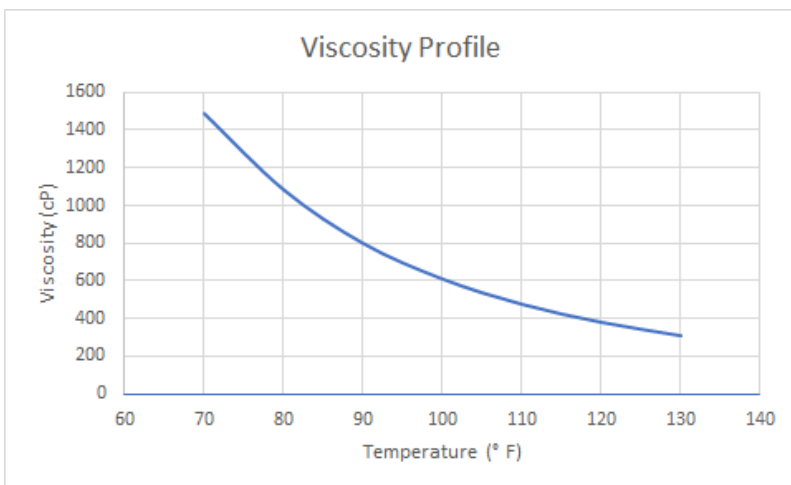
# Pluracol<sup>®</sup> 1026

Pluracol 1026 polyol is a high molecular weight triol developed for the manufacture of high resiliency molded foams. HR foams made with Pluracol 1026 in combination with graft polyols, such as Pluracol 4830, process well and are easily crushed.
