Lupraphen 1803/1 is a polyethylene/polybutylene adipate with a molecular weight of 1,000. It is often used in high property polyurethane elastomers, elastomeric coatings and adhesives applications.

Storage

Lupraphen 1803/1 containers should be kept tightly closed away from moisture and foreign materials. It is hygroscopic and tends to absorb water which may adversely affect processing. Use of a dry nitrogen blanket for partial drums is recommended. Storage temperatures should be maintained at room temperature or higher, not to exceed 75°C
